Dear Camp Trailer Owner,

The Town of Naples has, once again, contracted G&K Associates to assist with the appraisal of taxable personal property for the April 1st assessment date. This includes processing declarations for businesses and camp trailers located in the Town of Naples. You have received this because we have a record of your camp trailer/camper located in Naples.

Enclosed is the Town of Naples annual Camp Trailer Declaration Form You must complete and return this form on or before May 1, 2026.

Be advised that Camper/Camp Trailers are taxable in the State of Maine. **Owners have two (2) options for tax compliance.** You may pay the tax through a current registration with a Department/Bureau of Motor Vehicles (DMV/BMV) or pay the tax locally through the Town of Naples.

- **REGISTERED CAMP TRAILERS:** If your camp trailer is registered, please complete the enclosed declaration form, and return it *with a copy of your current registration showing taxes paid*. This will be noted in the Town's database. Please send the required documents by May 1, 2026.
- **UNREGISTERED CAMP TRAILERS:** If your camp trailer is not registered, it must be assessed a value through NADA. The year, make, model, and length are key to determining the used fair market value. Please complete the enclosed declaration form and return it by May 1, 2026.

Please be advised that if we do not receive your declaration form (and a copy of your registration if applicable), an estimated value will be determined, and a tax bill will be sent.

If you no longer have a camp trailer in the Town of Naples, please return the enclosed declaration form with details and date of sale/move so we may update our records. On-site visits will be conducted as needed to verify the reported information.
