- 1. Call to Order and Salute the Flag T. Shane called the meeting to order. Also present were C. Brackett, S. LaPointe, W. Adams, and K. Rogers (via Zoom). J. Rogers was also present.
- 2. Review of Meeting Minutes from January 8, 2024 C. Brackett made a motion to approve. Seconded by W. Adams. All in favor. Motion carried 5-0.

- 7. New Business
 - a. PROCLAMATION/2023 Spirit of America Tribute Naples Lions Club (represented by Dave Gerrish) – T. Shane read the proclamation and presented the tribute. D. Gerrish spoke briefly and thanked the Board for the tribute.
