

Please show location of trees in reference to property lines and bodies of water, using the point system. This system, which assigns values to trees down to two (2) inches in diameter, requires a certain total value of trees be maintained in each 25-foot by 50-foot square rectangular (1250 square feet) area within the buffer strip. Adjacent to great ponds, and rivers and streams flowing to great ponds, a rating score of 24 or more points must be maintained. Adjacent to other water bodies, tributary streams, and wetlands, a "well-distributed stand of trees and other vegetation" is defined as maintaining a minimum rating score of 16 per 25-foot by 50-foot rectangular area. Use additional paper if necessary.

Diameter of tree at 4.5 feet above ground level (inches)	Points
2 - less than 4	1
4 - less than 8	2
8 - less than 12	4
12 or greater	8
